

#### Staying Ahead of the Curve - Implementing effective arbitration agreements

An examination of most commercial contracts governing international agreements will reveal a clause dealing with alternative dispute resolution, specifically mediations and arbitrations.

The oft-quoted advantages of arbitration, as opposed to litigation, usually revolve around control; in terms of privacy, timing, flexibility and cost.

Arbitrations are conducted in private, as opposed to litigation which is open to public scrutiny. Parties to an arbitration can also control the timing of the arbitration process, since they have chosen and employed the arbitrators conducting the process. There is also the benefit of avoiding trial by jury. As a result of this control, arbitrations are routinely used to resolve international disputes.

#### Litigation Funding - Handling commercial and financial disputes



The complexity of global commerce inevitably leads to disputes between parties doing business together across borders, cultures and time zones.

The increasing frequency, scale and complexity of commercial disputes has subsequently led to a rise in litigation and arbitration proceedings as a means of resolution. While the costs of initiating court proceedings aren't usually prohibitive, the ongoing costs associated with litigation, such as attorney's fees and fees for discovery and depositions, can quickly stack up. The same is true for arbitration, where administration and arbitrator fees charged by international arbitration centres can lead to exorbitant costs to see a case through to conclusion.

For claimants based outside the European Union, in dispute with European defendants, there are also other barriers to consider, such as huge security deposits designed to cover the costs of the defendant should the case be lost.

#### The Art of Arbitration - Exploring efficiency in international dispute resolution

Commercial disputes are common in business, with many organisations handling multiple disputes on a domestic or international level in the course of their activities. The efficient resolution of those disagreements is crucial to ensuring costs and time are kept to a minimum, allowing the companies involved to focus on their primary operations without the distraction of a complex dispute.

Litigation is acknowledged as a difficult, time-consuming and expensive process, often requiring multiple hearings and appeals that can alter resolution timescales significantly. As a result, arbitration has become established as a viable alternative, often preferred because of its efficiency and transparency.

There are a number of high profile arbitration institutions that have an established set of rules and procedures accepted and implemented by all signatory countries. This level playing field has given organisations greater confidence to engage in international trade and commerce, without the spectre of costly litigation proceedings in a foreign legal system they have minimal understanding of.

### Case Study #1:

# Effective UK/German co-operation resolves contractual issue for a bespoke manufacturer of model motor vehicles

Colman Coyle are pleased to have been able to work with, and be involved, a significant number of referrals to and from, a large number of IR Global Members.

Howard Colman is the exclusive commercial litigation and arbitration member for England and is frequently involved in providing advice to, and seeking advice from, firms around the globe in relation to cross-border disputes.

A good example of the benefits, not only for member firms, but also for clients of the relationships formed through IR Global, arose in a piece of commercial litigation which Howard successfully concluded quite recently.

Howard was approached by Urs Breitsprecher of Aquan Rechtanswalte who was acting for a German manufacturer of bespoke model vehicles for international collectors in a potential claim for damages arising out of a breach of contract by an English company.

The contractual arrangements between the clients did not specify the applicable law nor the jurisdiction. It would have been possible to construct arguments both for English law and German law.

Howard worked with Dr Jana Schott, a partner in Aquan, to determine not only which law was most likely to apply, but also the commercial and strategic benefits for the client of each jurisdiction and system of law.

They jointly concluded that it was best to commence proceedings in England and to run the case under English law. This ultimately proved to be a good decision as, amongst other things, through the English procedure of disclosure, Howard was able to obtain a significant number of crucial internal documents from the English company which significantly strengthened the case.

These documents would not have been available to the client through German proceedings and the provision of them ultimately contributed significantly to a highly satisfactory settlement being obtained for the client.

### Case Study #2:

# Dispute Arising out of Hit Television Program

The benefits of having legal counsel who is a member of the IR Global community are substantial and important. The below case study high-lights the importance of having attorneys who can provide their clients with local representation as well as global coverage for the increasingly international, cross-border aspects of business and commercial disputes

IR Global member Erwin Shustak's firm, based in California, represented the creator of the international hit television show The Voice. That client had a dispute with a Netherlands company, and others, who he alleged purloined his intellectual property. The dispute wound up in litigation in the California court.

Since several of the defendants were Dutch, and their business activities governed by the Dutch courts, there was an ancillary court proceeding that needed to be commenced and pursued in the Netherlands to obtain information and documents pursuant to Dutch law. Erwin contacted his friend and colleague, IR Global member John Wolfs of Wolfs Advocaten, based in Maastricht, Netherlands, who acted as local counsel to the client in coordination with Erwin's firm. John pursued the legal proceeding in the Netherlands which allowed their joint client to obtain the information and documents necessary to pursue his primary dispute in California




### Case Study #3:

### Successful International Arbitration involving multiple IR Global members

The expertise and presence of IR Global Disputes members can be shown in a case of international arbitration between an Italian manufacturer of cookware and its German distributor over trademark and contract issues. As the Distribution Agreement was subject to Italian law but containing an arbitration clause in favour of the Arbitration Institute of the Stockholm Chamber of Commerce, the attorney representing the Italian plaintiff, Tommaso Mancini, from the Pesaro-based IR Global member Bacciardi & Partners representing the plaintiff retained the services of Dan Engström from Advokatfirman Nova AB, the Swedish IR Global member specialized in disputes and arbitration. Coincidentally, the German defendant in this dispute was represented by Dr. Ulrich Reber from the Munich office of the German IR Global member firm SKW Schwarz Rechtsanwälte. As the legal matters were all subject to Italian substantive law, SKW Schwarz engaged the services of yet another IR Global disputes member, i.e. those of Massimo Boni of the Milan-based firm Ferrari Pedeferri Boni. The parties brought the dispute to an amicable settlement. The fact, however, that this case of international arbitration involved four IR Global disputes members from different jurisdictions shows that clients trust in the competence of IR Global members when it comes to matters of cross-border litigation and when collaboration across several countries is needed.
